FREE High's Hurricanes for a Year Contest

NO PURCHASE NECESSARY TO ENTER OR WIN.

- 1. **CONTEST DATES:** The Contest begins at 12:00 a.m. Eastern Time ("ET") on May 1, 2024 and ends at 11:59 p.m. ET on June 31, 2024 (the "Contest Period").
- 2. ELIGIBILITY: Contest is open to legal permanent residents of Maryland and Delaware who are at least eighteen (18) years of age or older (or at least the age of majority in his/her state) at the time of entry (the "Entrant"). Then, once a High's Rewards member, scan your High's Rewards member card, use the High's Rewards mobile app, or enter your alternative ID at the point of sale at the time of purchase to receive one (1) entry into the Contest. A qualifying purchase is defined as payment for merchandise which includes a 'High's Hurricane' product. All purchase entries must be received by close of business on June 30, 2024.

By becoming a High's Rewards member, he/she agrees to the Terms and Conditions set forth by the Sponsor.

Entrant will need to provide all of the required information as requested in order to become a High's Rewards member. Upon completion of a purchase of a "High's Hurricane", Entrant will automatically receive one (1) entry into the Contest. Entries must be postmarked by June 30, 2024 and received by July 7, 2024. Each envelope is considered one (1) entry into the Contest. Multiple entries submitted in the same envelope are void.
